

** FAB INDEX – PRESS RELEASE **

The technical bit...

Over the month to 30 September 2018, First Actuarial's Best estimate (FAB) Index remained stable, with the UK's 6,000 defined benefit (DB) pension schemes maintaining a healthy surplus of £412bn.

The deficit on the PPF 7800 Index improved over September 2018 from £65.3bn to £38.7bn, and the funding ratio also improved from 96% to 98%.

These are the underlying numbers used to calculate the FAB Index:

The overall investment return required for the UK's 6,000 DB pension schemes to be 100% funded on a best estimate basis – the so called 'breakeven' (real) investment return – has remained at minus 0.9% pa. That means the schemes need an overall actual (nominal) return of 2.7% pa for their assets to meet liabilities.

The assumptions underlying the FAB Index are shown below:

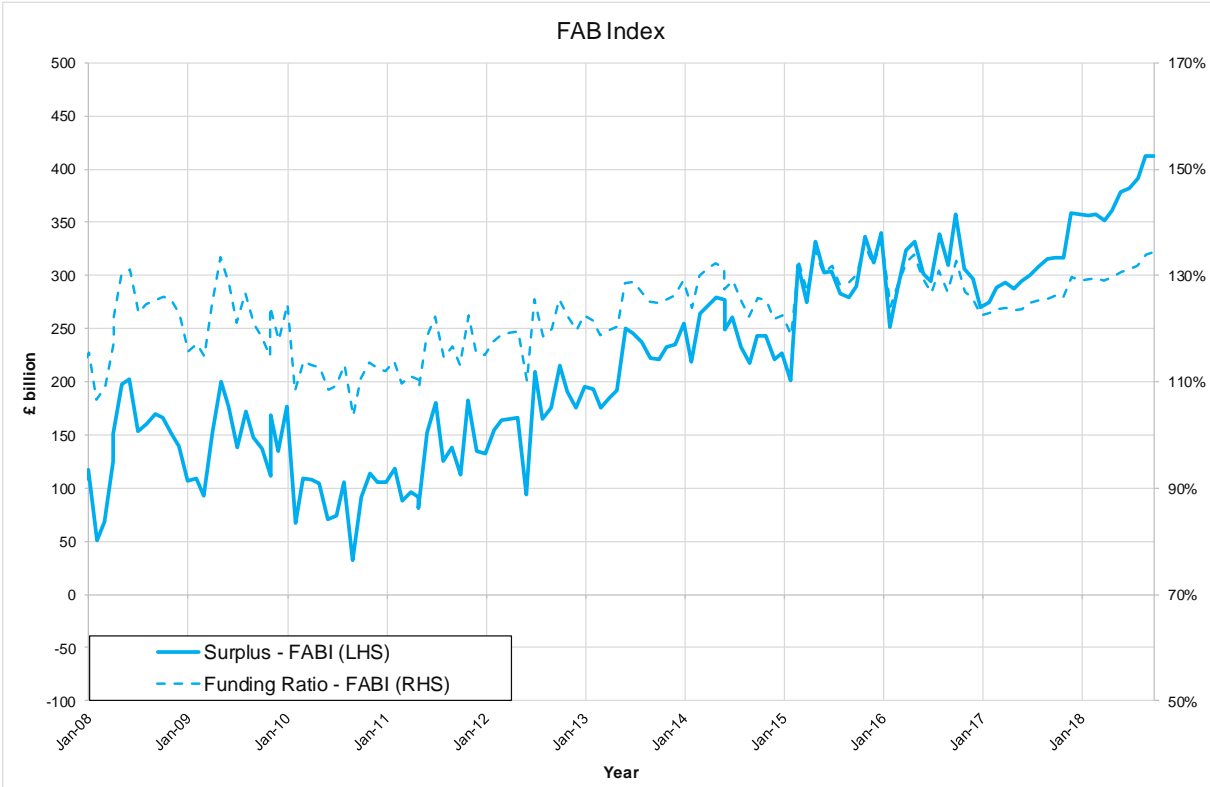

Notes to editors

The FAB Index is calculated using publicly available data underlying the PPF 7800 Index, which aggregates the funding position of 5,588 UK DB pension schemes on a section 179 basis, together with data taken from The Purple Book, jointly published by the PPF and the Pensions Regulator.

The FAB Index is updated on a monthly basis, providing a comparator measure of the financial position of UK DB pension schemes.
