

## **\*\* FAB INDEX – PRESS RELEASE \*\***

### **The technical bit...**

Over the month to 31 December 2018, First Actuarial's Best estimate (FAB) Index fell slightly, with the surplus in the UK's 6,000 defined benefit (DB) pension schemes decreasing from £446bn to £432bn.

The position on the PPF 7800 Index deteriorated over December 2018 from a surplus of £14bn to a deficit of £32bn, and the funding ratio fell from 101% to 98%.

These are the underlying numbers used to calculate the FAB Index:

The overall investment return required for the UK's 6,000 DB pension schemes to be 100% funded on a best estimate basis – the so called 'breakeven' (real) investment return – has increased to minus 1.0% pa. That means the schemes need an overall actual (nominal) return of 2.6% pa for their assets to meet liabilities.

The assumptions underlying the FAB Index are shown below:

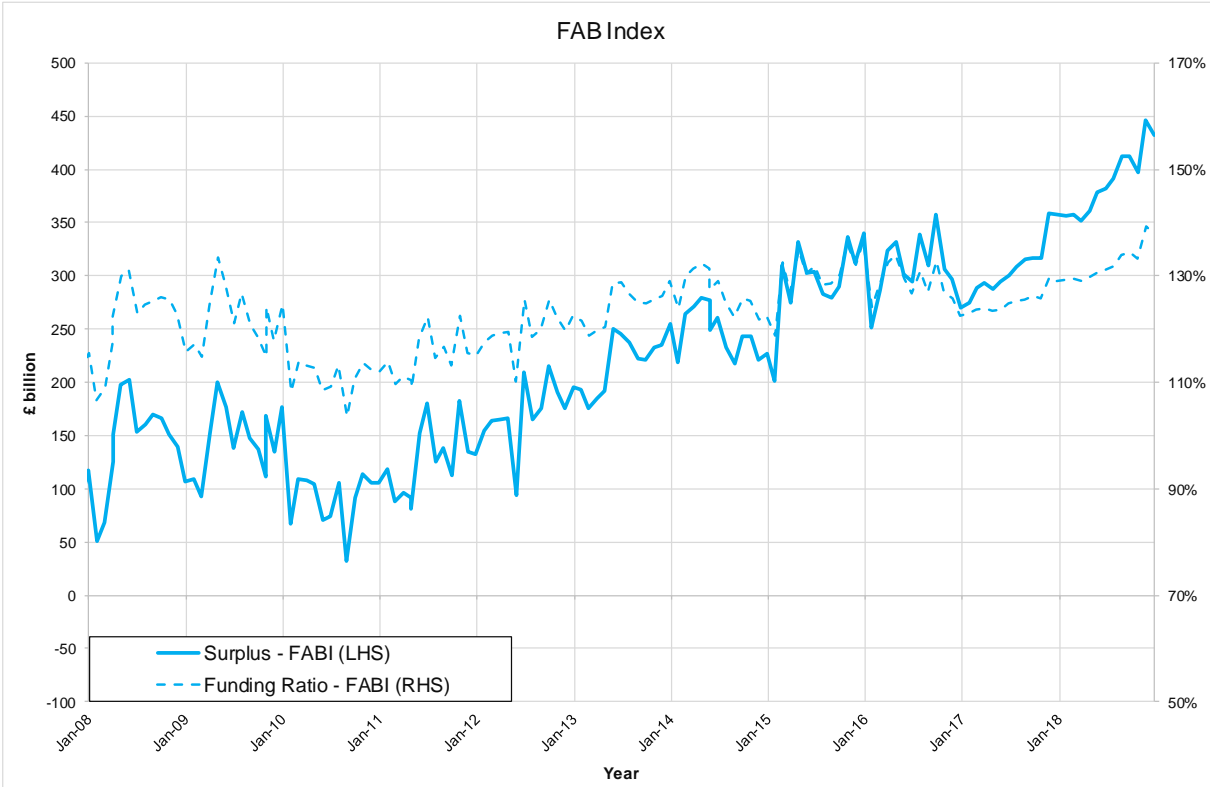

**Notes to editors**

The FAB Index is calculated using publicly available data underlying the PPF 7800 Index, which aggregates the funding position of 5,450 UK DB pension schemes on a section 179 basis, together with data taken from The Purple Book, jointly published by the PPF and the Pensions Regulator.

The FAB Index is updated on a monthly basis, providing a comparator measure of the financial position of UK DB pension schemes.
