## The technical bit...

Over the month to 31 October 2018, First Actuarial's Best estimate (FAB) Index fell slightly, with the surplus in the UK's 6,000 defined benefit (DB) pension schemes decreasing from £412bn to £397bn.

The deficit on the PPF 7800 Index deteriorated over October 2018 from £38.7bn to £107.7bn, and the funding ratio decreased from 98% to 94%.

These are the underlying numbers used to calculate the FAB Index:

The overall investment return required for the UK's 6,000 DB pension schemes to be 100% funded on a best estimate basis – the so called 'breakeven' (real) investment return – has increased to minus 0.8% pa. That means the schemes need an overall actual (nominal) return of 2.8% pa for their assets to meet liabilities.

The assumptions underlying the FAB Index are shown below:



### **Notes to editors**

The FAB Index is calculated using publicly available data underlying the PPF 7800 Index, which aggregates the funding position of 5,588 UK DB pension schemes on a section 179 basis, together with data taken from The Purple Book, jointly published by the PPF and the Pensions Regulator.

The FAB Index is updated on a monthly basis, providing a comparator measure of the financial position of UK DB pension schemes.
