

** FAB INDEX – PRESS RELEASE **

The technical bit...

Over the month to 31 July 2019, First Actuarial's Best estimate (FAB) Index improved, with the surplus in the UK's 5,450 Defined Benefit (DB) pension schemes increasing from £401bn to £416bn.

The deficit on the PPF 7800 Index increased during July 2019 from £51.7bn to £90.7bn, with the funding ratio decreasing from 97% to 95%.

The underlying numbers used to calculate the FAB Index are as follows:

FAB Index	Assets	Liabilities	Surplus	Funding Ratio	'Breakeven' (real) investment return
31 July 2019	£1,730bn	£1,314bn	£416bn	132%	-1.6% pa

The overall investment return required for the UK's 5,450 DB pension schemes to be 100% funded on a best-estimate basis – the so called 'breakeven' (real) investment return – has decreased slightly to minus 1.6% pa. This means the schemes need an overall actual (nominal) return of 2.0% p.a. for their assets to meet liabilities.

The assumptions underlying the FAB Index are shown below:

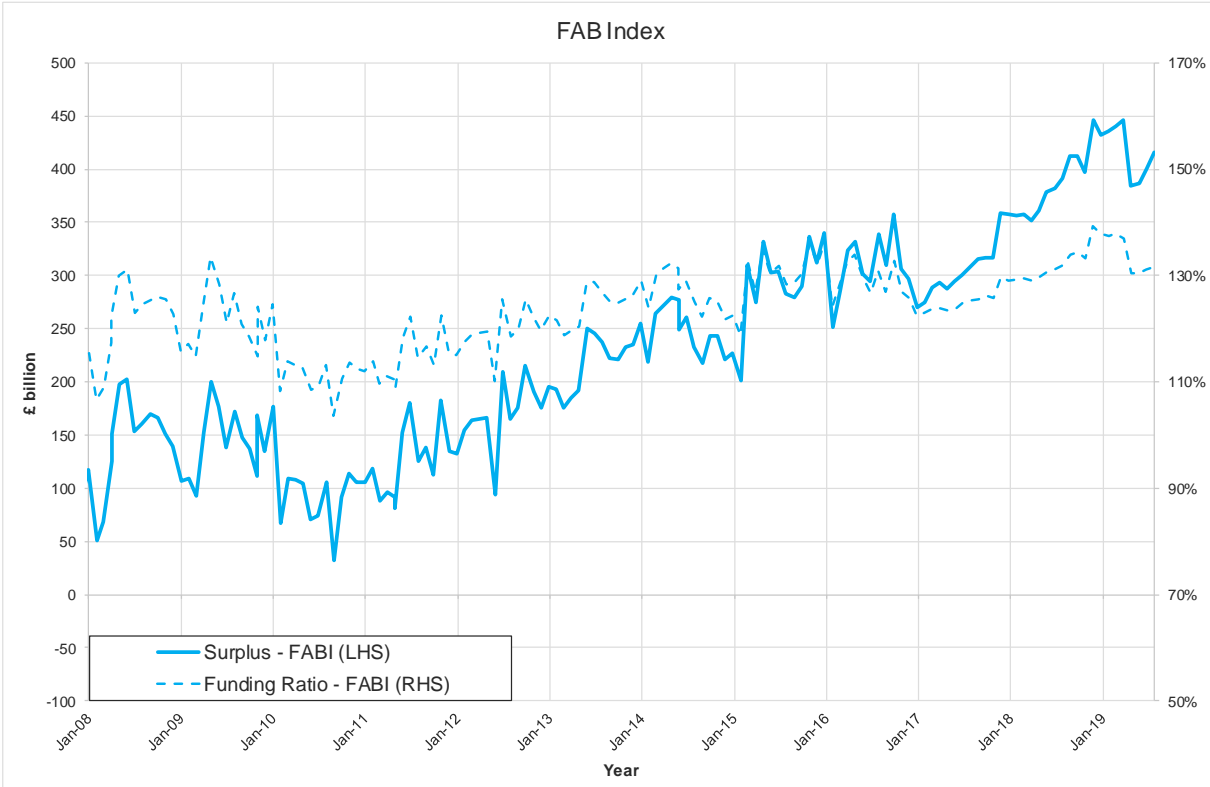

Notes to editors

The FAB Index is calculated using publicly-available data underpinning the PPF 7800 Index – which aggregates the funding position of 5,450 UK DB pension schemes on a section 179 basis – together with data taken from The Purple Book, published jointly by the Pension Protection Fund (PPF) and The Pensions Regulator.

The FAB Index is updated on a monthly basis, providing a comparator measure of the financial position of UK DB pension schemes.
