

## FAB INDEX

### The technical bit...

Over the month to 31 August 2020, First Actuarial's Best estimate (FAB) Index decreased slightly, with the surplus in the UK's 5,422 Defined Benefit (DB) pension schemes reducing from £328bn to £313bn.

The deficit on the PPF 7800 Index improved during August 2020, reducing from £199.5bn to £140.5bn, with the funding level increasing from 90% to 93%.

The underlying numbers used to calculate the FAB Index are as follows:

FAB Index over the last 3 months	Assets	Liabilities	Surplus	Funding Ratio	'Breakeven' (real) investment return

The overall investment return required for the UK's 5,422 DB pension schemes to be 100% funded on a best-estimate basis – the so called 'breakeven' (real) investment return – has increased slightly to minus 1.4% pa. This means the schemes need an overall actual (nominal) return of 1.7% pa for their assets to meet liabilities.

The assumptions underlying the FAB Index are shown below:

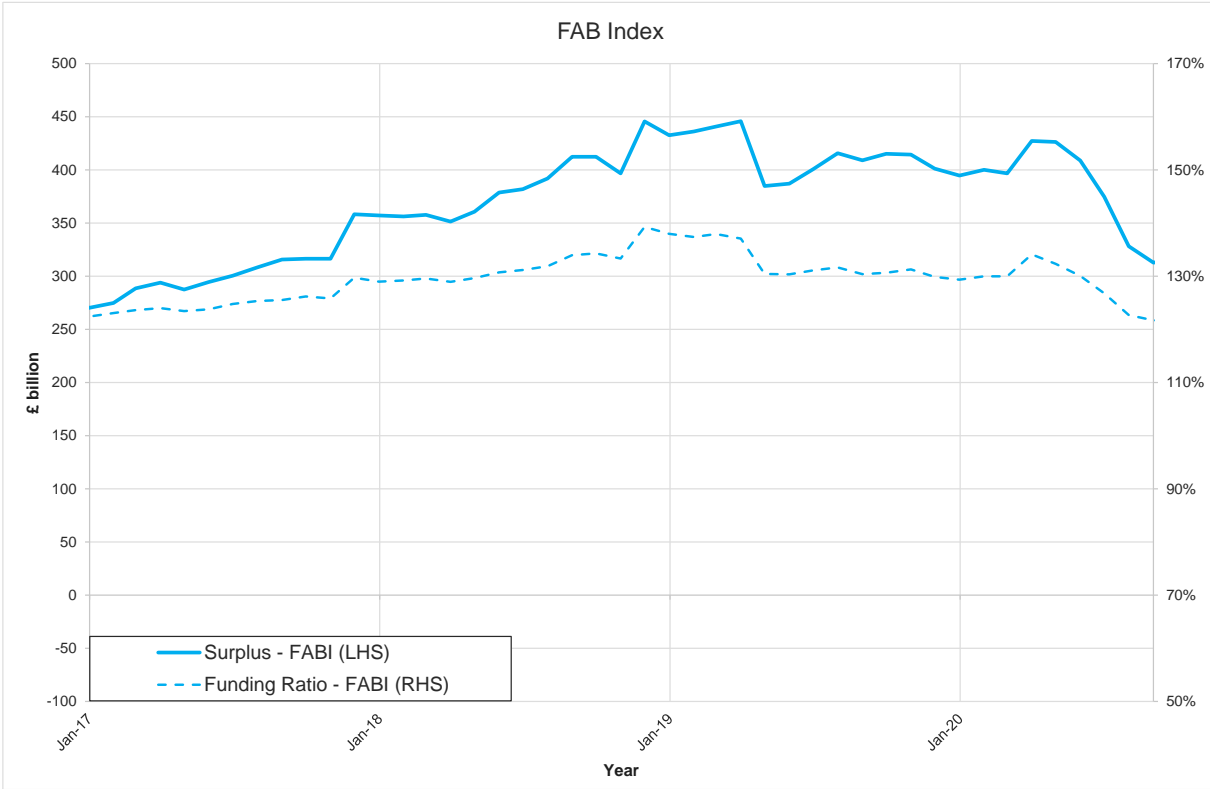
The weighted-average investment return is calculated assuming that schemes continue to invest in line with their current strategies indefinitely. In particular, we have not made any allowance for any changes that will be made to investment strategies to comply with The Pensions Regulator's future revised funding code.

**Whilst liabilities calculated on a best-estimate basis aren't suitable for scheme funding, we believe that trustees need this information, along with the buy-out solvency position, before they can arrive at a sensible value for funding.**

**Notes**

The FAB Index is calculated using publicly-available data underpinning the PPF 7800 Index – which aggregates the funding position of 5,422 UK DB pension schemes on a section 179 basis – together with data taken from The Purple Book, published jointly by the Pension Protection Fund (PPF) and The Pensions Regulator.

The FAB Index is updated on a monthly basis, providing a comparator measure of the financial position of UK DB pension schemes.
